- Show attire preferred but not required
- Please include a current negative coggins with entry
- One entry per horse/rider combo for CT divisions
- ALL RIDERS must wear an ASTM approved helmet with chinstrap attached while riding on the grounds
- Abuse of any animal will be cause for dismissal from the show
- No alcoholic beverages, or smoking allowed on the grounds
- Horses that kick MUST have red ribbons in the tail. Red ribbon will be available at Secretary's booth
- No stallions permitted on property

PLACINGS: Ribbons will be awarded for 1st-6th. Awards for Day's End High Point and Reserve Champion

ARMBANDS: Armbands are not required but are recommended

VESTS: Vests are not required but recommended for all stadium jumping. Required for any cross country schooling

WATER: Is available on grounds.

ARENA: All tests will be ridden in an indoor, small size dressage arena.

TIMES: Dressage & Stadium times posted Friday before show via email
